## THE PRE-AUTHORIZED GIVING PLAN

Looking ahead to the gradual induction of a cashless society, the Archdiocese of Toronto has established a Pre-Authorized Giving plan to help parishioners in their support of their local parish Church.

The following categories have been proposed for consideration:

- ❖ Offertory Contribution
- ❖ Building Fund
- ❖ ShareLife

### ADVANTAGES FOR THE DONOR

- ❖ Convenience.
- ❖ A saving on your cheques and consequent reduction in bank charges.
- ❖ Continual support of the parish church.
- ❖ Enables better planning of parish activities in order to serve you better.

In response to changing lifestyles and demands on time and energy, the Archdiocese of Toronto and Guardian Angels Parish seek, through the Pre-Authorized Giving plan, to assist you in your support of the parish and its activities.

Participation in the Plan creates a win/win situation for both, you and for our parish. It is a very simple procedure.

When you participate in the Pre-Authorized Giving plan, your monthly offering will be withdrawn from your bank account on or about the 20<sup>th</sup> of the month and will be directly deposited into the parish account.

This amount will constitute your monthly contribution to the Parish and will be receipted at the end of the year.

## CALCULATING THE MONTHLY PRE-AUTHORIZED GIVING

To help determine the amount of one's monthly deduction, the following calculation is presented as an example and guide.

Please note that the Special Diocesan Collections through the year have not been included in the calculation given below.

This calculation is based on the present averages.

Offertory:

Averages @\$10 per week x 52 weeks = \$520 /year

Building Fund:

Averages @\$10 per week x 52 weeks = \$520 /year

ShareLife:

Averages @ \$120 per year = \$120

Total Contribution for the year: \$1160

To calculate the monthly Pre-Authorized Giving:

Divide \$1160 by 12 = 96.66 per month

Round up to \$100

Suggested Pre-Authorized Giving:

\$100 per month\*

\*(This is only a suggestion. It does not preclude greater generosity.)

### **TO ENROL IN THE PRE-AUTHORIZED GIVING PLAN**

- ❖ Decide the amount of your monthly contribution to the parish in respect of the three categories presented earlier, and which you wish to be deducted every month from your account.
- ❖ Fill out and sign the form on the reverse of this brochure.
- ❖ Put both, the signed form together with a cheque marked "void" across it into an envelope.
- ❖ Place the sealed envelope in the collection basket or mail/hand in at the Parish Office.

### **WHO LOOKS AFTER THE PLAN?**

The office of Stewardship and Development of the Archdiocese of Toronto administers the Pre-Authorized Giving plan for Guardian Angels Parish.

### **HOW WILL PRE-AUTHORIZED GIVING REPLACE MY CURRENT GIVING?**

- ❖ Plain envelopes are available for any additional donations. Please ensure that you clearly print your name & address. This will substitute Offertory envelopes.
- ❖ These envelopes may be placed in the collection basket during Mass.
- ❖ All receipt will be issued at the end of the year by the Parish Office.
